"Climate Risk for Directors and Senior Managers in Financial Services: understanding, measuring and integrating into risk assessment and strategy" provides a comprehensive Board level introduction to the essentials of climate risk for local financial services businesses.

Delivered over two interactive sessions, this course combines theoretical insights with practical tools to equip participants with the knowledge and skills needed to navigate the challenges and opportunities of climate change in financial services.

Participants will first explore the foundational concepts of climate science and global emissions trends before diving into practical methods for emissions measurement, scenario analysis, and integrating climate considerations into risk and corporate strategy. The course also addresses regulatory and disclosure requirements in financial services such as the Task Force on Climate-related Financial Disclosures (TCFD) and the International Sustainability Standards Board's (ISSB) global standards together with local regulations to ensure participants leave with actionable insights to apply in their roles.

## Course Content

### Session 1: Foundations of Climate Risk and Global Emissions

This session builds a foundational understanding of climate risk and introduces participants to its significance in corporate governance and strategy.

#### Understanding Climate Risk:

- Overview of physical and transition risks and their financial implications.
- Exploring the link between climate change and business risks, including operational, financial, and reputational impacts and financial stability.

- Analysis of historical and current emissions data, with a focus on key contributors.
- Understanding sector-specific risks and opportunities within financial services.

#### Introduction to Regulatory Frameworks:

- The evolving importance of climate disclosure in corporate governance.

#### Case Studies and Group Discussion:

- Analysis of organizations effectively addressing climate risks through strategy and disclosures.
- Group exercise: Map emissions sources for a hypothetical organization and identify associated risks.

- Tools for assessing Scope 1, 2, and 3 emissions in financial portfolios.
- Identifying climate-related risks and opportunities through data-driven methods.

#### **Scenario Planning and Strategic Decision-Making:**

- Applying scenario analysis to assess potential climate futures and business impacts.
- Developing mitigation strategies and aligning them with organizational objectives.

#### **Interactive Exercise and Takeaways:**

- Group activity: Develop a TCFD- and ISSB-aligned disclosure for a hypothetical regulated business.
- Templates and tools for emissions reporting, risk assessments, and regulatory disclosures to use post-course.
