Course Overview

The three-month Diploma in International Insurance Management is a new certificated qualification developed by the Sagacious Group of experienced insurance professionals in conjunction with the Guernsey International Insurance Association (**GIIA**) and the GTA University Centre.

This self-study qualification has been designed as a follow-on to the [Guernsey Certificate in International Insurance Management | GTA](#) (the completion of which is a pre-requisite) for those wishing to take their understanding and knowledge of the Guernsey international insurance industry to the next level.

The Diploma is assessed by way of a 5,000-word dissertation chosen by the candidate, and approved by the moderators, allowing the candidate to demonstrate that they have undertaken research in their chosen area and developed their original thought in the area.
